
3-3. Gripping force

Holding conditions.


• To lift workpieces vertically, be sure to take into consideration the acceleration rate, air pressure, impact etc., in addition to the mass of the workpieces.




• Consider the center of gravity of the workpiece to avoid moments being applied the magnet gripper as much as possible.




• If multiple magnet grippers are used for transferring a workpiece with a large surface area, properly allocate the magnet grippers to maintain balance.



 Horizontal movement of the magnet gripper may cause sideslip of the workpiece depending on the acceleration or friction coefficient between the pad and workpiece. Therefore, the acceleration rate of the lateral movement must be minimized.



•Use the magnet gripper for horizontal handling. Adequate safety factor needs to be considered for inclined handling or vertical



•Thin workpieces may be deformed during transportation. It is recommended to use multiple magnet grippers for scenarios such as this.

Calculate the required holding force.



5-1. Precautions for Design



1. Confirm the specifications.

Products represented in this catalog are designed only for use in compressed air systems (including vacuum).Do not operate at pressures, temperatures, etc., beyond the range of specifications, as this can cause damage or malfunction.(Refer to the specifications.)Please contact SMC when using a fluid other than compressed air (including vacuum).We do not guarantee against any damages if the product is used outside of the specification range.

2. Take safety measures (e.g. mounting protective covers) when there is a danger of fingers being caught between the magnet gripper and the workpiece or with moving workpieces causing personal injury.

3. Select a model whose holding force is compatible with the workpiece mass.

Expected holding force may not be obtained depending on the material or shape of the workpiece, please evaluate the safety against the fall of workpiece with actual machine.

4. Do not use in applications where excessive external force or impact force may be applied to the gripper.

5. Consider the possibility of a power source related malfunction.

Measures should be taken to prevent injury and equipment damage in the event that there is a power malfunction to equipment controlled by air pressure, electricity or hydraulics, etc.

6. Consider the action of the product in the event of an emergency stop.

Devise a safe system so that if a person engages the emergency stop or if a safety device is tripped during a system malfunction, such as a power outage, the operation of the magnet gripper will not cause a hazard to humans or damage the equipment.

7. Consider the action when operation is restarted after an emergency or abnormal stop.

Design machinery so that bodily injury or equipment damage will not occur upon the restart of operation. 8. Do not disassemble the product or make any modifications, including additional machining.

Doing so may cause human injury and/or an accident.

9. Refer to the Auto Switches Precautions (Web Catalog) if using with an auto switch.

10. Risk to people with pacemakers

The product has a magnet inside. It may interfere with the use of an electronic equipment such as a pacemaker. People with pacemakers should stay away from the magnet gripper or take safety measures to block the magnetic force.

Caution

If pressure is applied to the external magnet gripper parts, there is a possibility that air will get inside the cylinder from the rod seal section. (Example : inside a chamber, etc.) Keep away from objects which are influenced by magnets.

As the body magnets are built-in, do not allow close contact with magnetic disks, magnetic cards, or magnetic tapes. Data may be erased.



5-2. Installation

1. Keep the manual in a safe place for future reference. The product should be mounted and operated only after thoroughly reading the operation manual and understanding its contents. 2. Ensure sufficient space for maintenance activities.

When installing the products, allow access for maintenance and inspection.

3. Observe the tightening torque for screws.

Tighten the screws to the recommended torque for mounting the product.

4. Do not place a magnetic object near the product.

The auto switch is a magnetic sensing type product. If a magnetic object is placed close to it, the product could operate suddenly, which could pose a hazard to humans or damage the machinery and equipment. When the magnet grippers are used in parallel, keep the specified cap between them to avoid malfunction. **5. Do not perform additional machining to the product.**

Additional machining to the product can result in insufficient strength and cause damage to the product. This can lead to possible human injury or damage to the surrounding equipment.

6. Do not enlarge the fixed orifice by modifying the pipe connectors.

If the fixed orifice is enlarged, the speed of switching between holding and releasing increases which results in higher impact forces. This may lead to damage to the product, which can lead to human injury and damage to other equipment and machinery.

7. When the magnet moves toward the magnetic attraction surface, holding force is generated on the attraction surface, Make sure that holding force is not generated when working around the magnet gripper so that your fingers do not get caught in the magnet gripper.

1. Do not scratch or dent the magnet gripper by dropping or bumping it when mounting. Even a slight deformation can cause malfunction.


2. Be careful with the magnetic attraction of parts of objects around the magnet gripper when mounting the magnet gripper while it is in its holding position (the piston is on the attraction side). They may cause injury.

3. When mounting the product, tighten it with screws of appropriate length at an appropriate torque. Tightening with a torque greater than the specified torque can cause malfunction, while insufficient tightening can cause slippage and dropping.


4. Do not apply impact load to the center of the magnetic attraction surface.

Otherwise, it may result in a breakage or malfunction.

Mounting orientation: On robot arms adjust the robot arm position before mounting so that the mounting is easy.




How to Mount Magnet Gripper (MHM-25D-X7400A-HC10DT,HC10)

(1)Mounting orientation: On robot arms

Let the connectors and cables coming out of the end of the robot arm out of the escapement groove of the flange.

Make sure that the cable is not caught by the hexagon socket head cap screw when it is tightened. * The drawing shows the flange for MOTOMAN-HC10.




(3) Connecting the M8 connector (2)Mounting to the robot arm. - Mount the conversion cable to the M8 connector. Hexagon socket head - After mounting the conversion cable, connect cap screw (M6 x 23) the robot arm end connector and conversion Max. tightening torque : cable connector. 5.2Nm * Do not energize while securing the connector. * Check that the connector is not loose. M8-Molex Conversion cable Either the robot side connector S1 or S2 can be connected. Positioning pin TI Robot arm end


(4) Secure the cable

Cable is secured by the INSULOK® tie and cable tie mount included in the accessories.

* After securing the table, cut off the excessive part of the INSULOK® tie.




 * Use a cross recessed resin round head screw (M4 x 6) as a plug when the INSULOK® cable tie is not used.




Operation time adjustment method for holding / releasing the workpiece

The piston operation time during workpiece holding / release can be adjusted by adjusting the opening of the metering speed controller valve.



- * (1) Workpiece holding time: Time required when the piston and magnet travel from the workpiece release position to the workpiece holding position
- * (2) Workpiece release time: Time required when the piston and magnet travel from the workpiece holding position to the workpiece release position



- * Use a flat blade screwdriver for adjusting the restriction of the metering valves.
- * Keep the restriction of the two metering valves approximately the same. If they are different too much, the operation may become unstable.

5-3. YASKAWA Plug & Play Kit


The YASKAWA Plug & Play Kit allows you to easily connect the magnet gripper to the robot and operate it.

5-3-1. Installing YASKAWA Plug & Play Kit

The YASKAWA Plug & Play Kit is installed by means of the YASKAWA Installation Packages(.yip) file. * Set the security access level to the administration level.

1.Download YASKAWA Installation Packages "SmcMagnetGripperExt.yip" from the SMC website.


2.Copy the downloaded file to a USB memory stick, insert the stick to the USB port of the smart pendant, select [MENU] on the upper left of the screen, and tap [System settings] -> [Packages].



3. Open the "Packages" tab and tap [+INSTALL] at the upper part of the screen. A pop-up dialog box showing the installable packages will appear. From the package list, select "SMC Magnet Gripper" and install it.

Normally, when the installation has completed, the packages, extension, and tool presets are added to the appropriate list.





5-3-3. Utility Window

1.Select [MENU] at the upper left of the screen, tap [Utility] -> [SMC Magnet Gripper], or tap [JOGGING] on the job contents review screen and then tap the "Magnet gripper" icon at the lower right of the screen to open the utility window.





- 2. Utility Window Features
- (1) Manual operation

It is possible to check the manual operation of the Magnet gripper.

By tapping the HOLD or RELEASE button, it is possible to perform a holding or releasing action of the gripper.


(2) Monitor sensor Signal

It is possible to confirm whether the Hold or Release position auto switches react.



5-3-4. Magnet Gripper Integration Window

1.On the Job Contents review screen, tapping [MAGNETGRIPPER] on the navigation bar opens the "Magnet Gripper" Integration Window.



2. Insert Commands Tab

(1) Selection Operation

Select the behaviour of the Hold or Release operations.

HOLD ONLY

Puts the gripper into the "Hold state", recognises it as" Hold success" without checking the Hold position signal, and proceeds to the next operation.

HOLD AND CHECK SIGNAL

Puts the gripper into the "Hold state" and waits for the Hold position signal input before proceeding to the next operation. When the signal is turned on, the software recognises it as "Hold success" and proceeds to the next operation.

RELEASE

Puts the gripper into the "Release state", recognises it as "Release success" without checking the Release position signal, and proceeds to the next operation.

RELEASE AND CHECK SIGNAL

Puts the gripper into the "Releasing state" and waits for the Release position signal input before proceeding to the next operation. When the signal is turned on, the software recognises it as "Close success" and proceeds to the next operation.

(2) INSERT COMMAND

It is possible to add commands for controlling the gripper holding/releasing action to the job.

SMC_HOLD_MAGNETGRIPPER


This command is used to make a gripper holding action.

If you select "Hold ONLY" or "HOLD AND CHECK SIGNAL" this command will be added.

• SMC_RELEASE_MAGNETGRIPPER

This command is used to make a gripper releasing action.

If you select "RELEASE ONLY" or "RELEASE AND CHECK SIGNAL" this command will be added.



3. Installation Settings Tab

* To change the setting, set the security access level to the administration level.

(1) Gripper operation completion waiting time

This is the set value for the waiting time after the valve is operated for the gripper holding/releasing action to turn on.

Adjust the holding of the exhaust restrictor and enter an appropriate value according to the gripper holding/releasing operation time. The default value is 500ms. It can be set in the range of 0 to 1000ms. (2) Status signal output to digital output port.

Select whether to output a status signal to the digital output port when "Hold/Release success" or "Hold/Release failure" is detected.

When "Enabled" is selected:


Selection of the digital output port is enabled. If either of "Hold/Release success" and "Hold/Release failure" is detected, the corresponding digital output port is turned on.

When "Disabled" is selected:

The selection of the digital output port is disabled. Even if either of "Hold/Release success" and "Hold/Release failure" is detected, no status signal is output.

(3) Select a digital output port

Selected box operation is enabled when "Output status signal to digital output port" is enabled. Select the digital output port to which a status signal is output when "Hold/Release success" or "Hold/Release failure" is detected.



4. I/O Settings Tab

* To change the setting, set the security access level to the administration level.

(1) I/O settings for gripper operation

At the time of installation of the YASKAWA Plug & Play Kit, the I/O assignment is already set. If wiring is made as per the manual, it can be used with the default setting.

However, if the wiring is changed to connect with another device, it is possible to change the signal setting for gripper operation from this tab.

If you intend to return the I/O setting to the factory default condition, pressing the button at the lower part of the screen can initialize this setting.

(2) Tool setting for the gripper

The collaborative robot calculates the external force by canceling the tool mass. For this purpose, it is necessary to set the tool to be mounted on the manipulator and the masses and the centers of gravity of the tool and workpiece should be set in the tool file.

In the initial setting, the tool number 0 is selected when the HOLD button is pressed. Tool number 1 is selected when the RELEASE button is pressed. The tool number can be changed.

The manual operation of the magnet gripper can be checked.

By tapping the HOLD or RELEASE button, it is possible to perform a holding or releasing action of the gripper.

(2) Monitor sensor signal

It is possible to confirm whether the Hold position or Release position auto switch reacts.

5-4. Air supply

1. Type of fluids

Please consult with SMC when using the product in applications other than compressed air.

2. When there is a large amount of drainage

Compressed air containing a large amount of drainage can cause the malfunction of pneumatic equipment. An air dryer or water separator should be installed upstream from filters.

3. Drain flushing

If condensation in the drain bowl is not emptied on a regular basis, the bowl will overflow and allow the condensation to enter the compressed air lines. This causes the malfunction of pneumatic equipment. If the drain bowl is difficult to check and remove, the installation of a drain bowl with an auto drain option is recommended. For compressed air quality, refer to the SMC Best Pneumatics No. 6 catalog. **4. Use clean air.**

Do not use compressed air that contains chemicals, synthetic oils that include organic solvents, salt, corrosive gases, etc., as it can cause damage or malfunction.

▲ Caution

1. When extremely dry air is used as the fluid, degradation of the lubrication properties inside the equipment may occur, resulting in reduced reliability (or reduced service life) of the equipment. Please consult with SMC.

2. Install an air filter.

Install an air filter upstream near the valve. Select an air filter with a filtration size of 5 μ m or smaller. **3. Take measures to ensure air quality, such as by installing an aftercooler, air dryer, or water separator.**

Compressed air that contains a large amount of drainage can cause the malfunction of pneumatic equipment, such as magnet grippers. Therefore, take appropriate measures to ensure air quality, such as by providing an aftercooler, air dryer, or water separator.

4. Ensure that the fluid and ambient temperatures are within the specified range.

If the fluid temperature is 5°C or less, the moisture in the circuit could freeze, causing damage to the seals or equipment malfunction. Therefore, take appropriate measures to prevent freezing. For compressed air quality, refer to the SMC Best Pneumatics No. 6 catalog.

5. Precautionary measures against condensation

Moisture condensation can occur inside pneumatic systems due to a drop in temperatures caused by the piping or operating conditions. This can degrade or wash away grease, resulting in a shortened service life or a malfunction. For details, refer to the catalog "Precautionary measures against condensation in a pneumatic system" (CAT.P-E01-11).

5-5. Piping

∠!\ Caution

1. Refer to the Fittings and Tubing Precautions (Best Pneumatics) for handling one touch fittings.

2.Before piping, blow air (flush) or clean the piping to remove any cutting chips, cutting oil, dust, etc.

5-6. Operating environment

🗥 Warning

1. Do not use in an atmosphere containing corrosive gases, chemicals, sea water, water, water steam, or where there is direct contact with any of these.

Refer to each construction drawing for information on the materials of magnet grippers.

- 2. Do not expose the product to direct sunlight for an extended period of time.
- 3. Do not use in a place subject to heavy vibration and/or shock.

4. Do not mount the product in locations where it is exposed to radiant heat.

5. Do not use in dusty locations or where water, oil, etc., splash on the equipment.

6. A decrease in the base oil of grease may be accelerated by the properties of the compressed air used in pneumatic equipment, the external environment, operating conditions, etc., and the resulting drop in lubricating performance may have an effect on the equipment's service life.

1. Internal lubricant or the base oil of grease may seep out of the cylinder depending on the operating conditions (an ambient temperature of 40°C or more, pressure retention, low-frequency actuation, etc.). Take great care when a clean environment is required.

5-7. Lubrication

Caution

1.Magnet gripper is lubricating non-lube type.

These cylinders have been lubricated for life at the factory and can be used without any further lubrication. However, in the event that it is additionally lubricated, be sure to use class 1 turbine oil (with no additives) ISO VG320. Do not use machine oil or spindle oil. Stopping lubrication later on may lead to a malfunction because the new lubricant will displace the original lubricant. Therefore, lubrication must be continued once it has been started. If turbine oil is used, refer to the corresponding Safety Data Sheet (SDS).

6. Maintenance or inspection

6-1. Maintenance or inspection

🗥 Warning

1. Perform maintenance and inspection according to the procedures indicated in the operation manual.

If handled improperly, human injury and/or malfunction or damage of machinery and equipment may occur. **2. Maintenance work**

If handled improperly, compressed air can be dangerous. Assembly, handling, repair, and element replacement of pneumatic systems should be performed by a knowledgeable and experienced

person.

3. Drain flushing


Remove drainage from air filters regularly.

4. Removal of equipment, and supply/exhaust of compressed air

Before components are removed, first confirm that measures are in place to prevent workpieces from dropping, run-away equipment, etc. Then, cut off the supply pressure and electric power, and exhaust all compressed air from the system using the residual pressure release function. When machinery is restarted, proceed with caution after confirming that appropriate measures are in place to prevent sudden movement.

There is a strong magnet in the magnet gripper. Do not disassemble the product as the magnet may attract parts and peripheral objects which may cause an accident. When it is necessary to disassemble, please contact the SMC Sales representative.
