1. TSCA

Under the TSCA, the United States Environmental Protection Agency (EPA) published a final rule in the Federal Register dated 6 January 2021 which bans the manufacturing, processing and commercial distribution of products and articles containing five persistent, bioaccumulative and toxic chemicals (PBT Chemicals).

The EPA has announced that it will extend this grace period for PIP (3: 1) until March 8, 2022. The EPA will determine the final effective date by the extended March 8, 2022.
